### **LaFleur Named Acting Chairman of FERC; Commissioner Bay Resigns**

Cheryl LaFleur has been named as Acting Chairman of the Federal Energy Regulatory Commission (FERC) by President Trump (announced January 26). Thursday afternoon Commissioner Norman Bay, who has served as Chairman since April 2015 submitted a [letter of resignation](#), effective February 3. This leaves FERC with only two sitting Commissioners, three vacancies and no quorum.

LaFleur, a Democrat member of FERC since 2010, previously served as Chairman from July 2014 until April 2015. She was previously a utility industry executive. The now three vacancies that President Trump must fill will require Senate confirmation. They will presumably be Republican appointments since the other remaining Commissioner, Colette Honorable is also a Democrat.

### **Trump's Executive Actions: What Do They Mean for Proposed Pipelines?**

This week's flurry of Executive Memoranda and Orders signed by President Trump have included several actions with relevance to the proposed Atlantic Coast Pipeline and the Mountain Valley Pipeline. Here's a rundown of some of the actions taken and links to them:

- [Expediting Environmental Reviews for Priority Infrastructure Projects](#)  
Provides for governors to request of the Chairman of the White House Council on Environmental Quality (CEQ) that a project in their state requiring federal agency approvals qualify as a "high priority" infrastructure project. If so designated, the CEQ Chairman would coordinate with relevant federal agencies to establish "expedited procedures and deadlines for completion of environmental reviews and approvals for such projects." Pipelines are cited among the eligible infrastructure projects. A list of 50 priority infrastructure projects, compiled by the Trump transition team, was released this week. The Atlantic Coast Pipeline was listed as project #20, the only pipeline project included.
- [Reviving the Keystone XL Pipeline](#)  
Invites TransCanada, the builder of the proposed oil pipeline, to resubmit its application to the Secretary of State, who in turn is directed to reach a permitting decision within 60 days. The final Environmental Impact Statement issued by the State Department in 2014 is to be considered satisfactory. The U.S. Corp of Engineers and U.S. Department of Interior are to expedite consideration of permits they are respectfully responsible for

issuing. All of that notwithstanding, state approvals will still be required. While TransCanada says it will reapply, the *Toronto Globe and Mail* observed January 25 that “oil prices remain half what they were just three years ago, and Canadian oil-sands producers face increasing competition from U.S. shale firms for market share,” so market realities may be a factor as to whether the project is indeed revived.

- [Reversing Corp of Engineers Decision on Dakota Access Pipeline](#)

This Presidential Memorandum directs the U.S. Corp of Engineers to “review and approve in an expedited manner, to the extent permitted by law and as warranted, and with such conditions as are necessary or appropriate, requests for approvals to construct and operate the DAPL” and to “consider, to the extent permitted by law and as warranted, whether to rescind or modify” previous actions taken by the Department of the Army in December and January that stopped the project. Lots of “ifs” and “buts, and legal challenges will most certainly occur whatever further decisions are made.

- [Construction of American Pipelines](#)

Requires the Secretary of Commerce within 180 days to “develop a plan under which all new pipelines, as well as retrofitted, repaired or expanded pipelines, inside the borders of the United States, including portions of pipelines, use materials and equipment produced in the United States, to the maximum extent possible and to the extent permitted by law.” Lots of questions, including: 1) Would pipelines that haven’t been approved be affected if they have already signed contracts with suppliers? 2) How would it affect the Keystone XL, to be built by across Canada as well as the U.S. by a Canadian-based company? 3) Is there enough domestic steel capacity to satisfy the requirement? Currently 1/3<sup>rd</sup> of all steel used in the U.S. is imported.

## Forest Service Communications Still Needed

This week’s Executive Actions by President Trump are reminder of how important it is that the government agencies responsible for making decisions concerning the environmental and safety dimensions of the Atlantic Coast Pipeline be encouraged to perform due diligence in accordance with the law. Last week’s *Update* requested that special communications be sent to top officials in the U.S. Forest Service, urging that they:

- 1) Conduct a complete and thorough review of the pending application for a special use permit for the ACP, as required by law; and
  - 2) Do not amend the existing Forest Plan for the George Washington National Forest.

## VOF Decision Two-Weeks Away

A decision by the Virginia Outdoors Foundation (VOF) on whether to accept or reject the application to permit the Atlantic Coast Pipeline to compromise conservation easements of 10 properties in the path of the project is expected to be made when the VOF Board of Trustees meets on Thursday, February 9 beginning at 10 am (note this is an hour later than previously announced) at the Virginia Department of Game and Inland Fisheries, 7870 Villa Park Drive, Suite 400, Henrico, Va. 23228. Public comments will be accepted.
